Our national leadership of the Council have circulated widely your good meeting with them in your constituency of Assam some time back and how you welcomed them and attentively heard the matters submitted to you. They submitted that a) All States to be informed to start Christian Finance Corporations, b) To intimate all DGPs and SPs (Superintendents and Chiefs of Police) to take any acts of religious intolerance seriously and nip it in the bud to see that it doesn't repeat itself c) that a meeting of Key leaders of our community be held either in Delhi or elsewhere to gather important leaders and that there is deliberation on how the community could improve its service to the nation.

We look forward to your office to study the above submissions and see what could be done. In Delhi & National Capital Region we also have noticed an increase in the number of attacks on the Christian Minorities and appeal to you to kindly inform the law enforcing authorities to be alert to stop any such incidents in the future.

The need for a Christian Finance Corporation for the welfare of NCR & Delhi region too may be kindly looked into and the necessary communication be made to the Delhi government to form this corporation as soon as possible.

We also extend a warm welcome to you sir to be our Patron for National Christian Council as we are based in Delhi, it will be our joy and privilege to take your advice and guidance from time to time on matters pertaining to Christian Minorities and on the issues of the Development of Nation by spreading brotherhood and good will to all. We look forward to your confirmation on this sir.
